When do I use this form?	<p>You can join a plan:</p> <ul style="list-style-type: none"> • Between October 15 – December 7 each year (for coverage starting January 1). • Within three months of first getting Medicare. • In certain situations where you're allowed to join or switch plans. <p>Visit www.medicare.gov to learn more about when you can sign up for a plan.</p>
